Description of Services

The client agrees that True Romance Video will be the exclusive professional videographer retained for the purpose of capturing your event. Videographers will arrive at the ceremony location approximately 45 minutes prior to ceremony start time to set up. Your service will be captured using as much natural light as possible; additional portable lighting is used when permitted. We use wireless UHF microphones to capture your vows and give you professional audio. In some cases these microphones may receive interference from outside sources or the house audio system. In extreme situations of interference, this microphone will be pulled. You can expect delivery of your finished DVD approximately **6 -8 weeks** from your reception date or your final payment collection date, whichever is later.

Your edited DVD will run up to 60 minutes or up to 120 minutes according to package details. It is assumed that the video demo, along with package description, provides the general picture of a finished product. All videos are delivered in their final version. True Romance Video has artistic license of shot selections. *Additional Editing will be billed separately.*

Limitation of Liability

While every reasonable effort will be made to produce and deliver outstanding video of the wedding events, the videographer's entire liability to the client for any claim or loss arising from the videographer's performance is limited to a refund to the client's amount paid for services.

Payment Policy

A retainer in the amount of one-third of the total amount is due and payable to reserve your date. The remaining balance is due 15 days prior to ceremony. Late payments within the 15-day period must be made via money order, cash or credit card. Unpaid balances will result in a cancellation of this contract and loss of any funds paid. All payments are non-refundable, except as noted in the Work Agreement.

Package Downgrade

There is absolutely no downgrading of packages. Failure to abide to active contract will result in cancellation of that contract and forfeiture of all funds paid. To continue service a new contract agreement must be completed and new retainer made.

Cancellation Policy

Cancellations must be made in writing 30 days prior to the ceremony date. If cancellation takes place within 30 days of the event, no funds will be returned and the total amount is still due and payable.

Meals, Lodging & Mileage

Travel expenses such as parking, shipping, or destination fees will be added to the balance at contract agreement. A light meal is required for events up to 4 hours. For events up to and past 6 hours a full course meal is required. If no meal is provided, it is understood that personnel of True Romance Video will leave the event to obtain a meal.

Substitution Policy

In the event of an unforeseen event out of the control of either party, True Romance Video will be allowed to substitute a videographer. This substitution will be only for camera operation at the event to produce the raw footage. Editing will still remain the obligation of True Romance Video.

Work Agreement

I hereby commission True Romance Video to video my event as outlined above and agree to pay for the services in accordance with the terms of purchase. In the event that True Romance Video is unable to perform the agreed upon services, I am entitled to a full refund. I agree to pay all reasonable court costs and attorney fees involved with the collection of any monies owed. I understand that there is a \$35.00 returned check fee. True Romance Video may use all or part of the video for display, promotional or other reasonable purposes in any variety of medium.
